**Agenda Item**: Declaration and Sale of Surplus Property

**Explanation**: The Police Department recently replaced three copiers. The replaced copiers

still function. The hard disk drive (HDD) on each copier has been overwritten to preserve the security of the information previously on the volatile memory. In

addition, there are several other items no longer useful to the department. Attached are a resolution and ordinance declaring the items as surplus and

authorizing disposal through sale or donation.

**Fiscal Impact**: Sale or donation would eliminate the expense of taking the items to a recycler.

Konica, the copier vendor, would charge \$400 to remove & recycle the

machines, while Kuusakowski Recycling would recycle without charge if the

items were delivered. Sale is expected to bring nominal revenue.
